**CIRCULAR**

**SELECTION TRIALS FOR PARTICIPATION OF DELHI BADMINTON, PARA BADMINTON, TABLE-TENNIS AND PARA TABLE-TENNIS TEAMS IN INTERNATIONAL TOURNAMENT.**

The Tokyo Metropolitan Government, the Tokyo Sport Benefits Corporation, the Tokyo Badminton Association and the Tokyo Table-Tennis Federation will be hosting the “14<sup>th</sup> Asia Junior Sports Exchange Games 2022” to be held from September 14<sup>th</sup> to September 20<sup>th</sup>, 2022 in Tokyo.

This Government intends to nominate its Badminton and Table-Tennis teams for participation in these Tournaments.

Badminton & Table-Tennis: - The city team will consist of 06 players in each game (03 Boys and 03 Girls). The player should be under 16 years old (Born on or after January 1, 2007).

Para Badminton & Para Table-Tennis: The city team will consist of 02 players in each game (1 Boy and 1 Girl). The player should be Under- 40 years old (Born on or after January 1, 1983).

For Para Badminton players, disability equivalent to SL4 and SU5 and for Para Table Tennis players, disability equivalent to STANDING from 8 to 10 (Refer ITTF standard) may apply.

There shall be no relaxation in prescribed age under any circumstances.

Each player shall bear all responsibilities for accident and health insurance as well as civil liability. The insurance must have coverage that includes Japan. This government shall not be responsible of liability of accident, illness, injury and death of any participant.

Tokyo Metropolitan Government shall bear: -

1. Round trip economy class air tickets between the International Airport of New Delhi and Narita Airport or Haneda Airport.

2. Expenses for a 6 nights/ 7 days stay at an accommodation which it will designate. The costs of all food and drink which is not included in the meals provided by them shall be borne by the player.
3. Local transportation expenses in Japan for the matches will be provided by them. All travel expenses for personal travel not included in the tournament scheduled shall be the responsibility of each participating player.

All other expenses shall be borne by the respective participating individual player.

Accordingly, the entries are invited from the desiring eligible players who fulfil the above criteria for participating in selection trials. The participating player for selection trials:

- i. Should be a bonafide resident of Delhi, for the last three years in case of disabled and non-disabled categories.
- ii. Should be a student of recognised school of Delhi, in case of non-disabled players.

The entries are to be submitted, strictly in prescribed Entry Form, along with supporting documents mentioned in the Check List. The entry may be submitted at Chhatrasal Stadium, Model Town between 09:30 AM to 06:00 PM, up to 05.07.2022.

The list of successful candidates for preliminary trials shall be displayed at our official website i.e. [www.edudel.nic.in](http://www.edudel.nic.in) on 08.07.2022.

The trials will be conducted at Thyagraj Stadium, INA, Delhi from 10.07.2022 to 12.07.2022.

Note:

1. Only those participants having valid passport at the time of selection trials will be allowed to give trials.
2. The disability certificate of the para players should have been issued by the competent authority on or after 01.01.2022 only.
3. As it is a team event (for non-disabled players), the players selected for participation in the above tournament are bound to play either singles only or doubles only or mixed doubles only. Decision of the team management

will be final in this regard. Non-cooperation of the players in this regard will be viewed seriously.


4. The players who have already participated in these games in the past are not eligible for participation.

The Directorate of Education reserves the right of final selection of the teams and its decision shall be abided by. In case of any dispute, the decision of the Directorate of Education will be final.

## CHECK LIST

### DOCUMENTS TO BE SUBMITTED

1. Entry form duly filled-in all the columns & signed by the Head of the School where the student is at presently studying. In case of disabled players, if not studying anywhere, the Entry form is to be attested by a Gazetted Officer.
2. Attested copy of Date of Birth certificate issued by concerned MCD/NDMC issued within one year of actual birth date of the child.
3. Attested copy of proof of continuous residence of player in Delhi for the last 3 years prior to the date of trials. The residence proof should bear the name of the player.
4. Attested copy of passport of player.
5. Attested copy of Class X certificate (wherever applicable)
6. Details of participation in Delhi state and National tournaments in the last 3 years along with attested copies of supporting certificates.
7. Attested copies of Report Card/ Progress Report of player for the last 3 academic year's i.e. 2019-20, 2020-21 and 2021-22.
8. Attested copy of disability certificate/ proof issued by a recognized Govt. hospital. Supporting documents/ certificate regarding disability equivalent to:
  - i. SL4 and SU5 in Para Badminton AND
  - ii. STANDING 8 to 10 (ITTF standard) in Para TT is a must.
