2. Hired vehicles should have DLY/DLT number used for commercial purpose for carrying passengers.
3. No dead mileage will be allowed.
4. The vehicles shall be used on working days and use shall be limited to 10 hours/100 K.M. per day.
5. The vehicles may be detained beyond 10 hours with the due approval of Dy. Director of Education.
6. The rate of extra mileage and detention charges in case of vehicles detained beyond 10 hours shall be specified by the owner of the vehicles.
7. The maximum ceiling per vehicle per month should not exceed Rs.25,000/-
