- Sealed tenders are invited for and on behalf of the President of India for purchase of 1 various items for the Independence Day 2008.
- 2 The tender shall consist of three separate bids -a pre-qualification bid, a list of The pre-qualification bid, a list of samples and the samples and a financial bid. financial bid should be sealed by the bidder in 3 separate covers duly superscribed and all these 3 sealed covers are to be put in a bigger cover which should also be sealed and duly superscribed which shall be deposited in tender box kept in the room of DDE (PE& Sports), at Chhattrasal Stadium, Model Town, Delhi. The tender shall be accepted, along with samples, upto 2.00 p.m. on 23-07-2008. No tender will be entertained thereafter under any circumstances.
- 3 Rates shall not be quoted on "Pre-qualification bid" form. In case they are mentioned directly or indirectly, the bid shall be summarily rejected.

In such cases, the Director of Education shall have the right to forfeit the earnest money/security or to take any legal action against defaulter contractor.
 - 9. The articles ordered / supplied would be subject to inspections by the authorized teams / representatives of the Director of Education, at any place to be decided by the Deptt. The goods supplied / ordered are liable to be rejected, if the same do not come up to the prescribed specifications / approved samples. The tenderer has to bear all the cost at his own risk.
 - 10. No interest on bid security or performance guarantee will be paid.
 - 11. The bid security of unsuccessful tenderer will be returned on finalization of the tenders.
 - 12. The payment towards the supply of the articles shall be made directly to the firm by the Directorate of Education, Delhi.
