- 2. The tender shall consist of two separate bids a technical bid and a financial bid. The technical bid and the financial bid should be sealed by the bidder in 2 separate covers duly superscribed and these 2 sealed covers are to be put in a bigger cover which should also be sealed and duly superscribed which shall be deposited in tender box kept in the room of **ADDL. The tenderer should submit the documentary proof of minimum turnover in the form of **P & L Account** of the firm indicating above for previous 3 years (i.e. upto 31.03.2010) with technical bid of the tender, duly verified by Chartered Accountant or certificate for the last three years duly **signed by CA**
