1. The bid should accompanied by the supporting document in respect of eligibility criteria otherwise the bid will be rejected.
2. The lowest bidder firm has to deposit performance security worth 20000/- in the form of cheque/draft/fdr/ bank guarantee in the favour of Principal and should be valid for six months. The performance security will be released only after completion of work and satisfactory report of VKS committee members.
3. If the firm faces to perform the work within 01 month of work order the performance security will be forfeited and firm may be blacklisted for 03 years in future.
4. The work should be completed 30 days of placing order otherwise 02% per week penalty will be imposed of balance work value.
5. Regarding quality and quantity of work done by the firm the final decision is vested only on the members of VKS committee and the decision of VKS committee members will be final and binding on the bidder.


