

2. The tender shall consist of two sealed covers consisting of a technical bid, and a financial bid. All these sealed covers inscribed in the bold letters on the envelope i.e. technical bid & financial bid shall be sealed in one big envelope due mentioning "Tender for HIRING OF DRESSES FOR STATE REPUBLIC DAY CELEBRATION-2016. 21. The quantity may increase or decrease as per the need of the programme.
