Kindly refer to this cell letter No. F/3/30/ACP Cell/ 2008/626/15611-5635 dated 19/3/08 and its subsequent clarification dated 07/0408 vide which you were requested to process and forward the cases for grant of ACP in respect of PGTs, TGTs, and other categories of teacher who are becoming eligible upto 31st March 2008. The last date of submission of Cases to District/ Headquarter was 25/04/2008, however so far all such cases have not been processed and forwarded. Various representations and enquiries from teachers are being received stating that their cases are not being now taken up HOS on unreasonable grounds. It is very sad that inspite of repeated warnings in the past for ensuring strict compliance for processing ACP, these red-tapism are coming to notice.

An indicative list of eligible cases of TGT and PGT was also sent to all DDEs/ ADEs of District to ensure that none of the deserving eligible candidates are left out while processing ACP Cases of teachers vide UO dated 10/04/2008.

It is found that the number of cases forwarded by Districts, especially

North, East, North East, North West B, West B and South are very poor. (La) - eules

All the Dy Director of Education, particularly the above referred defaulting Districts, are once again directed to send ACP Cases to headquarter latest by 15/05/2008. All the Dy Director of Education are further directed that they should advice HOS accordingly, in case necessary action is not taken, the explanation of the DDEs concerned shall be called
