SHOW CAUSE NOTICE

Whereas, various complaints have been received from the under mentioned Principals/HOSs of Government Schools with brief contents of complaint where the security services are being provided by the firm. Copies of the complaints are enclosed for ready reference.

1	SKV Gazipur, Delhi (1002184)	The services of deployed guard are far from satisfactory. HOS has also informed that on one night no guard was found present on duty.
2	GBSS Kondli Gharoli, Mayur Vihar Ph-III, Delhi-96 (1002263)	Services of the security is not satisfied
3	RSKV East Vinod Nagar, Delhi-91 (1002028)	HOS informed that the firm has submitted the bill from the month of December, 2011 for releasing the payment. They have also informed that a theft has occurred in the month of December, 2011 and request to how the matter sort-out and release the payment.

With the above act of misconduct the firm M/s Sarvesh Security Services Pvt. Ltd. has violated the terms and condition of award of contract and the agreement signed by the firm.

Now, therefore, M/s Sarvesh Security Services Pvt. Ltd. is hereby directed to explain their position as to why not penal action including forfeiting of the performance security and debarring/blacklisting the agency be taken against the firm. Their reply should be sent with five days of receipt of this SCN, failing which further action in the matter shall be taken ex-parte.
