SHOW CAUSE NOTICE

Whereas, M/s Sarvesh Security Service Pvt. Ltd., has been awarded the contract for providing of the Sanitation work in the schools as per terms and conditions of the tender of Directorate of Education w.e.f. 01/05/2011.

Whereas, complaints have been received from the Principals of the Schools where the sanitation services are being provided by the said firm:-

Head of school has informed that no employee/worker of the contractor has turned up in the school since 22.05.2012 despite several telephonic calls on provided telephone numbers of the firm resulting that heaps of garbage are lying here and there. Toilet blocks are in very bad condition and giving bad smell. Due to non cleanliness of the premises, there is a fear of spreading diseases.

On previous occasions also complaints have been received from the HOS and SCNs have been issued to M/s. Sarvesh Security Service Pvt. Ltd. on 29.11.2011, 12.12.2011 and 17.01.2012 but instead of improving sanitation services by the said firm, no sanitation workers has been provided since 22.05.2012.

With the above act of misconduct i.e. the firm has stopped providing sanitation services without any reason causing insanitation in the area, M/s Sarvesh Security Service Pvt. Ltd. has violated all the terms and condition of award of contract and the agreement signed by the firm. The firm is liable to face penal action.

Now, therefore, M/s. Sarvesh Security Service Pvt. Ltd. is hereby directed to show cause as to why not the contract of the firm be not terminated. The reply along with the reports of the concerned HOS should reach the undersigned within 5 days of the receipt of this letter, failing which ex-parte decision will be taken by competent authority. **This may be treated as final notice.**
