

The entire contract on a 'single responsibility' basis such that the amounts cover contractor's all obligations mentioned in or to be reasonably inferred from the Tender document in respect of the House keeping and sanitation services at Education Department, Govt. of NCT of Delhi, Delhi for a period of two year w.e.f. 01/05/2011 to 30/04/2013. The handing over taken over will be on 30/04/2011 after noon.

The firm is directed to comply with the following :-

1. The Award will be subject to the detail terms and conditions as indicated in tender document and also subject to signing of Agreement with the Department on Rs. 100/- non Judicial Stamp Paper within period of two weeks in CTB Branch HQ.
2. The Firm has to provide all Uniform, Badges, Identity Card and any other material required as per the terms and conditions laid down in the tender document with immediate effect.
3. The firm has to submit performance security amounting to Rs. 134000/- (One Lakh Thirty Four Thousand only) calculated on the basis of method adopted for EMD in favour of Director of Education, Govt. of NCT of Delhi in the CTB Branch, HQ within 10 days of issue of letter.
4. The list of zones allotted to the firms is attached. Each firm would ensure that private sanitation services are provided only in those schools where private sanitation services were already existing. These services will not be provided to any other school without approval of the competent authority.
5. The payments will be made by the HOS/DDO concerned on the basis of satisfactory services.
6. The agency has to provide the adequate number of staff and material for up-keeping the cleanliness the school as per the satisfaction of the HOS/in-charge concerned
