With the above act of misconduct the firm M/s Keshav Enterprises Company has violated the terms and condition of award of contract and the agreement signed by the firm. In this regard the reference is invited to the penal provision clause 9.3.7 of the award of contract.

Now, therefore, M/s Keshav Enterprises Company is hereby directed to explain their position as to why not panel action including for forfeiting of the performance guarantee and debarring the agency be taken against the firm. There reply should be sent within 5 days of receipt of this SCN, failing which further action in the matter shall be taken ex-parte.
