SHOW CAUSE NOTICE

Whereas, M/s Sarvesh Security Service Pvt. Ltd., has been awarded the contract for providing of the Sanitation work in the schools of Directorate of Education w.e.f. 01/05/2011 as per terms and conditions of the tender.

Whereas, a complaint has been received from the Principal of the School where the sanitation services are being provided by the said firm:-

Copy of complaint is enclosed for reference. The complaint is regarding non cleanliness of the School premises by the firm for sanitation purpose. School Authorities have been complaining to the firm but of no use.

Whereas earlier also on dated 29-11-2011 and 12-12-2011 Show Cause Notices were issued to M/s Sarvesh Security Service Pvt. Ltd. and verbal directions on telephone were also given to the firm but in spite of reputed letters from HOS, SCN from this office and verbal directions from concerned School in charge as well as this office, there is no improvement in sanitation services being provided by the firm. Rather it has deteriorated.

And whereas, by the above acts of misconduct, M/s. Sarvesh Security Service Pvt. Ltd. has violated the term and conditions of agreement and thus liable to be penalized.

Now, therefore, M/s. Sarvesh Security Service Pvt. Ltd. is hereby directed to show cause as to why not the contract of the firm be not terminated. The reply along with the reports of the concerned HOS where the sanitation services have not been found satisfactory till date should reach the undersigned within 5 days of the receipt of this letter, failing which ex-parte decision will be taken by competent authority. This may be treated as final notice.
