The above official may exercise option with regard to fixation of pay, if any as per FR-22(I) (a) (I) within one month of the issue of this order. The financial benefit allowed under the ACP scheme shall be final and no pay fixation benefit would be admissible at the time of regular promotion. Before implementing the said order, the Head of school will ensure that the concerned official has educational qualification for the promotional post scale of which has been awarded under ACPS, However in case of Isolated posts, no higher Education qualification is required as per RRs prior to the due date of ACP and has not refused normal vacancy based promotion. The service particulars of the official as received from the Distt. DDEs are also mentioned above which will be recheck by the concerned HOS/HOO before implementing the said Order and discrepancy, if any will be brought to the notice of ACP Cell within 7 days, failing which the responsibility will rest upon them. Further Head of school will also obtain a latest Vigilance report from the DDE concerned to the effect that the concerned official is free from Vigilance angle and no penalty was/is in operation on the date of grant of ACP/teas on date. While presenting arrears bill in the Pay & Account offce, the Head of school will certify that no vigilance case is pending against the official and acher has acquired the educational qualification as per RRs prior to grant of ACP and has not refused normal vacancy based promotion.
