DDEs are also mentioned above which will be recheck by the concerned HOS/HOO before implementing the said Order and discrepancy, if any will be brought to the notice of ACP Cell within 7 days, failing which the responsibility will rest upon them. Further Head of school will also obtain a latest Vigilance report from the DDE concerned to the effect that the concerned official is free from Vigilance angle and no penalty was/is in operation on the date of grant of ACP/teas on date. While presenting arrears bill in the Pay & Account offce, the Head of school will certify that no vigilance case is pending against the official and acher has acquired the educational qualification as per RRs prior to grant of ACP and has not refused normal vacancy based promotion. However, the grant of higher pay scale is subject to the undertaking from the beneficieries that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay or will be deposited by the beneficiery within two months of receipt of a demand notice.
