**OFFICE ORDER**

On the recommendations of Departmental Screening Committee meeting dated 17/07/2012 and with the prior approval of Competent Authority, the following (01) direct Lab Asstts (presently working/ retired as Lab Asstt in the pay scale Rs. 4500-7000 (Pre-revised) is hereby granted 2nd upgradation under ACP scheme in the pay scale Rs.5000-8000 (Pre-revised) as per their entitlement after competing 24 years of regular service, with effect from the date mentioned against each.

This financial up-gradation is purely personal to the incumbent and are restricted for financial and certain other benefits (HRA, Allotment of Govt. Accommodation, Advances etc) only. The above officials may exercise option with regard to fixation of pay, if any as per FR-22(I) (a) (I) within one month of the issue of this order. The financial benefit allowed under the ACP scheme shall be final and no pay fixation benefit would be admissible at the time of regular promotion. Before implementing the said order, the Head of school will ensure that the concerned official has educational qualification for the promotional post scale of which has been awarded under ACPS, However in case of Isolated posts, no higher Education qualification is required as per RRs prior to the due date of ACP and has not refused normal vacancy based promotion. The service particulars of the official as received from the Distt. DDEs are also mentioned above which will be rechecked by the concerned HOS/HOO before implementing the said Order and discrepancy, if any will be brought to the notice of ACP Cell within 7 days, failing which the responsibility will rest upon them. Further Head of school will also obtain a latest Vigilance report from the DDE concerned to the effect that the concerned official is free from Vigilance angle and no penalty was/is in operation on the date of grant of ACP/as on date. While presenting arrears bill in the Pay & Account office, the Head of school will certify that no vigilance case is pending against the official and acher has acquired the educational qualification as per RRs prior to grant of ACP and has not refused normal vacancy based promotion. However, the grant of higher pay scale is subject to the undertaking from the beneficiaries that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay or will be deposited by the beneficiary within two months of receipt of a demand notice.
