Therefore, all the HOSs/stadia/office incharges are hereby asked to furnish their report in the given format to the agency latest by date 23<sup>rd</sup> day of every month.

Further, the material for cleaning will be utilized by the agency as per requirement only. The non consumable items will be provided on one time basis. The agency is liable to provide new or repaired non-consumable items as and when such situations arise.

Further all the incharge of designated locations may note that non-receipt of report within three days of communication of billing cycle will be deemed that the agency is providing services as per satisfaction and the payment to the agency will be processed and disbursed as it involves payment of wages to the sanitation workers.
