In reference to circular No.- DE/23(386)/Sch.Br./2018/1146 dated 06-08-2018, regarding the National Mass Deworming programme on 10th August, 2018 followed by Mop up on 17th August, 2018, it is informed that 17th August, 2018 being a declared holiday, Mop up Day has been re-scheduled and will be held on 24th August, 2018 in all the Govt., Govt. Aided and Unaided recognised schools of Delhi while the rest of the contents of the circular will remain the same. The Albendazole 400mg Tablets of Batch No 360944 will not be used till further orders as these are under investigation for adverse effects. All the concerned Heads of the Schools where the Albendazole 400mg tablet of batch no 360944 have been issued can get it replaced from the department of school health scheme(DGHS) for the Mop of Day on 24th August 2018.(copy enclosed)
