**ORDER**

**Cancellation of appointment/posting order to the post of PGT  
(Geography) Post code (134/12)**

Whereas, Amit Dalal (DoB- 06/09/1980) (Roll No.-29000024) had been nominated by DSSSB for the post of PGT (Geography) against post code 134/12 vide letter No. F.1(158)/DSSSB-P&P/2012/208-10 dated 20/03/2017 result notice No. 472 dated 23/02/2017 and accordingly an offer of appointment was issued vide this office Memorandum of even No. dated 05/05/2017 for initial verification of documents.

2. Amit Dalal (DoB- 06/09/1980) (Roll No.-29000024) had been appointed vide order of even no. dated 07/12/2017 and been given Emp. I.D 20172251 and posted in Hastsal, Janta Flats-SBV-1618281 with the direction to join latest by 29/12/2017. The candidate as per representation having Dy No. 5678/E-II had sought extension on domestic grounds and same had been granted extension till 28/02/2018 and the candidate as per representation having Dy No. 720/E-II again sought extension due to domestic reason and the same had been granted upto 31/05/2018. The candidate once again sought extension having Dy No. 2155/E-II dated 25/08/2018 and in view of the fact the period of six months has lapsed, hence, no further request for further extension can be entertained.

3. Therefore, sufficient time and opportunity has been granted to Amit Dalal (DoB- 06/09/1980) (Roll No.-29000024) to join his place of posting. But Amit Dalal has chosen not to join the post of PGT (Geography), it can be seen that Amit Dalal is not interested to accept the appointment/posting order.

4. Further, DOPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned "An offer of appointment should be clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**"

5. Therefore, in view of para.2 to 4 the appointment/posting order dated 07/12/2017 in respect of Amit Dalal (DoB- 06/09/1980) (Roll No.-29000024) is hereby cancelled and the dossier is returned to DSSSB.
