Aided & Unaided Recognized Schools under Directorate of Education are hereby directed to sensitize the parents of the students of the respective schools about the worrisome air pollution situation prevailing in and across Delhi and further appeal them to restrain their children from undertaking outdoor activities till severe pollution condition persists. Outdoor activities and exposure in polluted conditions could have long term detrimental effects on health of children. Therefore, parents may be requested to adopt preventive approach to safeguard their Child's health. This information is to be disseminated to the parents through the students and SMC members of the school.



ORDER

Keeping in view Severe Air Quality conditions for the past 48 hours, in addition to the directions by EPCA issued vide letter no. DPCC/PA to MS/2018/7919-7956 dated 24.12.2018, all concerned departments/Agencies are directed to ensure compliance of following decisions;

1. Appeal to be issued to all parents by Education Department for avoiding outdoor activities by the children.
2. DTC and Transport Department to intensify public transport services.
3. DMRC to increase frequency of service of Delhi Metro.
4. Municipal Corporations and PWD to intensify mechanical road sweepings and sprinkling of water.
5. Municipal Corporations, DDA and DMRC to enhance parking fees by four times immediately till further orders.
6. Municipal Corporations to stop the use of fire wood and coal in hotels and eateries.
7. Municipal Corporations, DPCC and Industries Department to enforce ban on use of pet coke and furnace oil.
8. DPCC, SDMs, Municipal Corporations and Industries Department to strictly enforce ban on use of electricity generator sets with exceptions as defined by DPCC for essential services.
9. Municipal Corporations, DDA and SDMs to strictly enforce prohibition on open burning.
10. Municipal Corporations, DPCC and PWD to impose fine/penalties on all road construction agencies/contractors, where there are inadequate dust control measures.
