The redeployment of Guest Teachers for the session 2020-21, is to be carried out who have been relieved due to PFC/Promotion of regular teachers/joining of fresh recruits/transfers etc. as per existing policy of DoE.

Accordingly, the allotment to the eligible relieved candidates, who have been submitted their representation in the office of DDE East upto 13/11/2020, requesting for their re-deployment have been considered.

Allotment of schools have been done based on vacancies taken from MIS module as on 13/11/2020.

Guest teachers who have been allotted schools are hereby informed to report for joining in the office of concerned HOS within **next three working days**. At the time of reporting concerned Guest Teachers must carry following documents for verification by the concerned HOS:-

- 1. Copy of online Registration slip/Application Form.
- 2. Copy of latest online generated relieving letter having clearly mentioned reason of relieving of last attended school. In case of Transfer to District copy of the same may be obtained.
- 3. Copy of online generated experience certificate year wise.
- 4. Self attested photocopies of all relevant educational qualifications (both sides) like year wise Mark sheets/certificates, Provisional/Degree (from 10th onwards), CTET (wherever applicable).
- 5. Certificate issued by HOS of last relieved school stating documents related to educational qualification in r/o concerned guest teacher has been verified from concerned Board/University through online/offline mode.

Further, Concerned HOS will take following action/instructions for the engagement of Guest Teacher for session 2020-21.

- 1. Give the concerned Guest Teacher manual joining if the teacher fulfils all eligibility condition for his/her particular posts/subjects laid by DOE as per existing RR's.
- 2. Spelling of name in application form, certificates, and Aadhar Card should be same to avoid discrepancies during generation of remuneration.
- 3. Verify the age, qualification, result, marks sheet and online generated Experience certificate (no. of days) of the concerned candidate.
- 4. Concerned Guest Teacher must not be disengaged due to misconduct, misbehavior, remained absent without permission of the HoS, poor performance or resigned due to personal reasons.

- 5. Submit a copy of manual joining immediately in the O/o In Charge, Guest Tr. Branch (Distt. East), so as his /her name can be uploaded in MIS for online joining.
- 6. Thereafter, HOS may check the candidate name in MIS and generate online engagement letter.

Mere allotment of school does not ensure the engagement of the candidates; it is further subject to the availability of vacancy at the time of reporting in the allotted school and fulfillment of eligibility criteria as per existing RRs of DoE.

Further, concerned HOSs are directed to verify all documents of concerned Guest Teacher before his/her manual joining and in case of any discrepancy has been observed, intimate Guest Teacher Branch urgently and not to engage without consulting to the District Authority.

In case of non submission of certificate as stated at point no. 5 in the direction of the guest teacher concerned HOS after joining of eligible candidates, would verify documents submitted by concerned Guest Teacher from their respective boards/institution/universities offline or online mode. Furthermore, in case found any false/forge/incorrect information legal action against concerned Guest Teacher must be initiated under intimation to the District office.

For any query, regarding engagement of Guest Teachers HOS may contact to the In-Charge, Guest Tr. Branch (Distt. East).

Concerned HOS is fully responsible in case of any discrepancy found after manual/On line engagement of the guest teacher and action may be initiated as deemed fit.
