CIRCULAR

All the District Deputy Directors of Education, GNCT of Delhi and NDMC/Delhi Cantonment Board are hereby informed that the process for admissions in RPVVs in Class-XI is scheduled in the month of June-2017 for which detailed advertisement has been published in leading newspapers of GNCT of Delhi on 06.06.2017. The complete schedule is available on the official website of Directorate of Education i.e. www.edudel.nic.in. The date of registration for admission is from 07.06.2017 to 14.06.2017 and the Entrance Test is scheduled for 19.06.2017 (MONDAY). The criteria for admission in RPVVs Class-XI are as follows:-

The students who have passed Class- IX in the year 2016 and Class- X in the year 2017 from Delhi Government /Government Aided/NDMC/Delhi Cantonment Board Schools situated in GNCT of Delhi are eligible for registration for Entrance/Screening Test seeking admission to Class-XI in RPVVs. The registrations are opened in any RPVV for external candidates only if there are seats available after admitting all the eligible students of its own RPVV strictly as per the Merit criteria fixed by the Directorate of Education vide circular No.208 dated 06.06.2017 available on www.edudel.nic.in.

All the registered candidates will have to appear in an entrance test that will be held on the same date/time for all the RPVVs and the selection will be made on the common merit of the applicant in the Entrance Test of respective RPVVs. Where the applicant was registered and appeared in the Entrance Test. The Entrance Test will consist of objective type questions to test numerical ability, mental ability, general knowledge and language comprehension. In addition to above, there will be descriptive test for Hindi & English language (English for all the three streams (i.e. Science / Commerce / Arts) whereas Hindi for Arts Stream in addition to English Language).

Therefore, all the District DDEs of Dte. of Edn. and also of NDMC/Delhi Cantonment Board DDEs are requested to direct all the Heads of Government & Government Aided Schools under their jurisdiction to encourage the bright students to participate in the admission process for admissions in Class -XI of Rajikiya Priatibha Vikas Vidyalays.

Further, Worthy Director (Education) desires that all the Heads of Government & Government Aided Schools must convey the same to all the parents of all students who have passed Class-X, during Academic Session 2016-17.


