## **CIRCULAR**

Sub:- Engagement of Subject Specific Teacher (TGTs) and Primary Teacher working under SSA on contractual basis during the year 2017-18.

Sarva Shiksha Abhiyan (SSA), Delhi has been engaging Subject Specific Teachers (TGTs) and Primary Teachers on contractual basis as a temporary measure to address the increased enrolment of students in Govt. School. The contractual period of TGTs and the PSTs that were engaged for the year 2016-17 in DoE School ended on 31<sup>st</sup> March 2017 which was extended upto 10<sup>th</sup> May 2017 vide order No. F.DE (29)/UEEM/Access/2017-18/7381 -95 dt. 28.03.2017.

The Competent Authority on receipt of approval from MHRD for the teaching posts has decided to re-engage on contract basis the same set of Subject Specific TGTs and Assistant Teachers who were engaged in the year 2016-17 and have continued till 10.05.2017, by following the guidelines as stated below:-

- The contract teachers shall be re-engaged preferably in the same schools, subject to the requirement on the basis of enrollment of the school. In case of non requirement in the same school, the contract teacher shall be posted in another school within the same district.
- The contract teachers against whom there is a case of indulging in dereliction of duty, may not be considered for re-engagement. However, the approval of concerned DPO has to be taken in every such case keeping in view the facts & circumstances.
- The teachers who absented from their duties unauthorisedly without submitting leave application to HoS/DPO and have adverse report pending against them shall not be considered for re-engagement in the year 2017-18.
- 4. The re-engaged teachers shall not be asked to resubmit their original attested photocopies of documents as a routine. The originals and /or attested photocopies of required documents shall be called form only those teaches whose documents are not available with the District. However, reason for the same have to be recorded by the competent officer of District.

In view of above, all the DPOs/DDEs are hereby directed to take fresh agreement by issuing offer letter to all the contract teachers whose contract expired on 10.05.2016. 2017 The term of contract this year would be from 11.07.2017 to 31.03.2018.

This issues with the prior approval of the competent authority.
