Advaniji, Ex. Dy. Prime Minister & M.P. from Gandhinagar.

Hon. Minister Shri. Vijay Goyal visited on 22^{nd} October, 2016 to SAI, Gandhinagar and declared the Centre for Para Athletes only in the Country. III. Benefits of the Scheme are as follows:

- Boarding & Lodging facilities for 330 days in a year @ of 225/- per day per head for STC Schemes.
- 2. Sports kit @5000/- per head per year.
- 3. Sports Equipment (as required for Training).
- 4. Competition exposure in India & Abroad.
- 5. Medical Facilities
- 6. Insurance
- They may represent their Own State of Domicile in the National Championships & Other National Level Tournaments.

Playing Facilities: International standard playing facilities are available at SAI, NSWC, Gandhinagar.

Facilities are being created to provide total accessibility for the Para Sports Person. Presently, we are unable to provide access for wheel chairs and blind or anyone need compulsory assistance/ support; however, we may be able to provide such facilities in near future. Initially, we will be inducting those differently able sports persons who can manage on their own.

To start with three disciplines maximum 50 seats are available (Boys & Girls) which may vary discipline wise as per the requirement of (Para) Athletes available in that particular sports discipline.

Age Limit is within the Age of 12 to 18 years. Final selection will be done in all the three disciplines for induction in STC (Para) by the selection committee as given below, after the successful completion of the assessment camp in each sports discipline.
