CIRCULAR

Subject:- Re-deployment of Guest Teachers for the Academic Session 2017-18.

1. Vide order no. 18.2(36)/Plg./2016/2970-80 dated 03.03.2017, remuneration of guest teachers has been enhanced.
2. Guest teachers who have worked in Academic Session 2016-17 shall be re-deployed for the Academic Session w.e.f. 01st July, 2017.
3. In view of the above, all the HOSs are hereby informed that the Guest Teachers engaged upto 09th May, 2017 may be re-deployed w.e.f. 1st July, 2017 and such Guest Teachers are hereby directed to report to the HOS concerned on the date of re-opening of schools without fail. In case any Guest Teacher(s) fails to report to the schools by 08th July, 2017, it is presumed that he/she is no longer interested for empanelment and alternative arrangement will be made. However, Guest Teachers removed due to indiscipline, poor performance, mis-behaviour etc. shall not be re-deployed by the HOSs. The list of eligible teachers to be re-deployed will be displayed in the on-line module in respective schools and HOSs can issue deployment letter for the year 2017-18.
4. Further, HOS can remove the guest teacher, if found unfit in the online performance evaluation module for guest teachers which will be uploaded shortly. However, guest teachers who have been disengaged prior to 09th May, 2017, due to lack of vacancy in their earlier schools, (but not removed due to indiscipline/poor performance) during March-May, 2017, will be deployed suitably, in a different school, subject to non-availability of regular teacher in that particular category of post.
5. Guest teachers of TGT and Assistant Teacher (Primary) who will be re-deployed in the Academic Session 2017-18 without CTET qualification shall have to pass CTET upto 30th Sep, 2017, failing which their engagement shall be terminated.


