ORDER

Finance Department, Govt. of NCT of Delhi is pleased to revise the rate of per child expenditure payable towards admission of EWS/DG category students in private unaided recognised schools u/s 12(2) of RTE Act as indicated in the following table. The revised rates will be in force during 2018-19 & 2019-20.

This issues with the prior concurrence of Finance Department, Govt. of NCT of Delhi vide U.O. No.DSF-V/19 dated 02/07/2018.

The per child expenditure reimbursement/disbursement is subjected to the following conditions:

1. Every school shall maintain a separate bank account in r/o the amount received by it as reimbursement {referred to clause 11(2) of DRTE Rules}.
2. Every school shall provide free text books, writing material, uniform and other facilities such as library, information & communication technology, extra-curricular and sports etc. {referred to clause 10(2) of DRTE Rules}.
3. Re-imburement shall be restricted to the period, students studied in that school during the year.
4. School shall furnish utilization certificate to districts within two months of receipt of money and also furnish a certificate that it had provided uniform and text books to these students as prescribed by the school.



5. If it is found at a later date that the amount reimbursed to particular school is in excess of the expenditure actually incurred by the school, the same shall be recovered/adjusted from the amount admissible for the next academic session.
6. No fee shall be charged by school from EWS & DG category students admitted under the provisions of RTE Act.
