Further on checking of the data entered in respect of students of school education, it was observed that response is not upto the mark as only 698 nos. of application in Pre-Matric Scholarship and 604 nos. of application in Post Matric Scholarship have been submitted in the Portal. This could be due to lack of guidance to the students at the school level. Head of Schools (Government / Government aided / Private) are directed to give enough publicity to the above schemes by placing the information on the Notice Board, making announcement during the morning school assembly etc to enlighten the students, so that eligible among them can apply (Fresh/Renewal) in time.
