**ORDER**

**Cancellation of appointment/posting order to the post of PGT**  
**(Political Science) Post code (150/12)**

Whereas, Kiran Yadav, (DOB 09/04/1982) (R.No. 34003942) had been nominated by DSSSB for the post of PGT (Political Science) against post code 150/12 vide letter No. F.1(158)/DSSSB-P&P/2012/242-44 dated 23/03/2017 result notice No. 488 dated 17/03/2017 and accordingly an offer of appointment was issued vide this office Memorandum of even No. dated 08/05/2017 for initial verification of documents.

2. Ms. Kiran Yadav (DOB 09/04/1982) (R.No. 34003942) had been appointed vide order of even no. dated 21/07/2017 and been given Emp. I.D 20171665 and posted in Nariana, 1<sup>st</sup> Shift-SBV School ID. 1720002 with the direction to join latest by 31/08/2017.

3. However, Ms. Kiran Yadav sought extension as per letter the same had been granted till 15/09/2017. Accordingly, as per communication of even no. dated 02/11/2017 a final notice to Ms. Kiran Yadav was issued directing her to join on or before fifteen days from the date of said notice.

4. Therefore, sufficient time and opportunity has been granted to Ms. Kiran Yadav (DOB 09/04/1982) (R.No. 34003942) to join her place of posting. But Ms. Kiran Yadav has chosen not to join the post of PGT (Political Science), it can be seen that Ms. Kiran Yadav is not interested to accept the appointment/posting order.

Further, DOPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned "An offer of appointment should be clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**"

6. Therefore, in view of para.4 and DoPT OM dated 09.08.1995 the appointment/posting order dated 08/05/2017 in respect of . Kiran Yadav (DOB 09/04/1982) (R.No. 34003942) is hereby cancelled and the dossier is returned to DSSSB.
