ORDER

**Cancellation of appointment/posting order to the post of PGT
(Political Science) Post code (149/12)**

Whereas, Roshan Nain, (DOB 20/02/1982) (R.No. 34000331) had been nominated by DSSSB for the post of PGT (Political Science) against post code 149/12 vide letter No. F.1(158)/DSSSB-P&P/2012/242-44 dated 23/03/2017 result notice No. 487 dated 17/03/2017 and accordingly an offer of appointment was issued vide this office Memorandum of even No. dated 12/05/2017 for initial verification of documents.

2. Mr. Roshan Nain, (DOB 20/02/1982) (R.No. 34000331) had been appointed vide order of even no. dated 10/08/2017 and been given Emp. I.D 20171921 and posted in Nithari Village, SBV School ID: 1412092 with the direction to join latest by 31/08/2017.

3. However, Mr. Roshan Nain sought extension as per letter the same had been granted till 15/09/2017. Accordingly, as per communication of even no. dated 02/11/2017 a final notice to Mr. Roshan Nain was issued directing him to join on or before fifteen days from the date of said notice.

4. Therefore, sufficient time and opportunity has been granted to Mr. Roshan Nain, (DOB 20/02/1982) (R.No. 34000331) to join his place of posting. But Mr. Roshan Nain, has chosen not to join the post of PGT (Political Science), it can be seen that Mr. Roshan Nain, is not interested to accept the appointment/posting order.

5. Further, DOPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned "An offer of appointment should be clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**"

6. Therefore, in view of para.4 and DoPT OM dated 09.08.1995 the appointment/posting order dated 12/05/2017 in respect of Mr. Roshan Nain, (DOB 20/02/1982) (R.No. 34000331) is hereby cancelled and the dossier is returned to DSSSB.
