The payment will be will @ Rs. 22,288/- p.m. (Rs. Twenty two thousand two hundred eighty eight only) on consolidated basis.

Accordingly, applications are invited from desirous candidates, who are below the age of 45 years as on 01.03.2020, as per the prescribed RRs, and having the following qualifications:-

- (b) Swimming Training certificate from any recognized institute and two years experience in this field.

The presently engaged Life Guards will/ may also have to apply for the posts for skill test. However, they will not be replaced by any other set of Contractual Lifeguards as per the order of Hon'ble CAT in OA No. 2069/2017 Santosh Kumar (Lifeguard) & Others Vs GNCT of Delhi till the time orders are in force.

# Terms & Conditions for appointment of swimming life guards on contract basis.

- 1. The appointment will be made on the basis of skill test. The candidates who qualify in the skill test will be called for document verification.
- 2. The appointment can be terminated at one month notice from either side.
- 3. He/ She will not be entitled to the facilities like reimbursement of Medical expenses and Leave Travel Concession.
- 4. The contract appointment does not bestow any right upon the life guard for regular appointment in Department of Education.
- 5. They will accompany the respective school teams and school children of the school for participating in inter-zonal and other sports tournaments.
- 6. They will make aware the students with the first-aid techniques.
- 7. They will render their services in organization of various games/ competitions by Directorate of Education as well as in competitions/ games where Directorate of Education participates and any other duty assigned time to time.
- 8. They will organize general physical activities for all the school students for their further development in athletics, football, volleyball and badminton etc.
- 9. Once the swimming session is over, they will work under the overall supervision of the Head of the School. In case of double shifted schools, female life guards will work in the morning shift school and male life guards will work in the evening shift school.
- 10. The total working hours per day will remain the same throughout the contract.
- 11. They may be posted at any swimming pool of Directorate of Education.

A self declaration to the effect that applicant is not facing any enquiry, investigation or any other proceedings in relation to any criminal offence or allegation of moral turpitude and/or has not been convicted / held guilty by any Court or Authority in this behalf is also to be enclosed. Any applicant who has been removed from service on disciplinary grounds by D.O.E. is not eligible for fresh appointment.
