Aided Schools under Directorate of Education were informed about the online module for registering complaints regarding Sexual Harassment at Workplace and it was further directed to ensure that the above information be circulated among all the staff members and displayed at prominent places i.e. School main gate, outside Principal;s Office and Notice Board etc.

- After a complaint is received online through the above link, it is automatically reflected for processing and monitoring in the login of the Govt. and Govt. Aided School/Office/Branch to which it pertains and it can be accessed by the concerned School/Office/Branch as under:

- At the same time, the complaint is also reflected in the login of higher authorities (concerned RDE Office, Office of DDEs District and Zone) for monitoring and can be accessed through the same link i.e.,

At the Directorate of Education level, all complaints pertaining to all Govt. and Govt.
Aided Schools/Offices/Branches under Directorate of Education are reflected in the
login of RDE (Central) for monitoring purpose and can be accessed through the
same link i.e..

www.edudel.nic.in (Home Page) -> Login -> School Plant -> Complaints regarding Sexual Harassment at Workplace.

In view of the above, all RDEs, DDEs (District/Zone), Branch Incharges/Heads of Offices of Directorate of Education and all Heads of Govt. and Govt. All RDEs and DDEs (District/Zone) are also directed to monitor the processing of complaints by their subordinate Offices/Govt. and Govt. Aided Schools and ensure that the complaints are processed and disposed of in a time bound manner as per rules.
