ORDER

WHEREAS on the basis of the written examination conducted by Delhi Subordinate Services Selection Board Ms. Jayshree (Roll No. 69000097, D.O.B 19/09/1988), was provisionally selected & nominated for appointment to the post of Librarian under post code 02/13 in Directorate of Education, Govt. of NCT of Delhi & her dossier was received in this Directorate through DSSSB vide letter No. F. 1(157)/P&P/DSSSB/2012/1338-40 dated 28/12/2017.

And WHEREAS after completion of documents verification & receipt of her medical fitness report from Lok Nayak Hospital, Govt. of NCT of Delhi. Mrs. Ms. Jayshree was appointed to the post of Librarian vide order No.DE 04/06/406/Aptt. of Lib./Pt.f./2016/6042-46 dated 23/04/2019 (Posting ID 20190033) Further she was directed to join Paschim Vihar, B 3-G(Co-ed)SSS-1617137 by 10/06/2019.

And WHEREAS as per Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personneol & Training OM No. 35016/2/93-Estt. (D) dated 9thth Aug. 1995 "an offer of appointment should clearly specify the period (which shall not normally exceed one or two months) after which the offer would lapse automatically if the candidate **did not join within the specified period.** If however within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministries/Depts. and it may be granted only as an exception where facts and circumstances so warrant and in any case only **upto a maximum of six months from the date of issue of the original offer of a appointment.** An offer of appointment would lapse automatically after the expiry of six month from the date of issue of original offer of appointment.

And WHEREAS she was granted extension for joining time upto 10/06/2019 vide memorandum dated 01/08/2019. But she did not join.

And WHEREAS on her request letter dated 19/09/2019 for extension in joining time was considered & she was again granted extension for joining time upto 22/10/2019. But Ms. Jayshree has failed to join her place of posting i.e. Paschim Vihar, B 3-G(Co-ed)SSS-1617137 within the specified period, given in the letter.

And WHEREAS despite providing sufficient time and opportunities to Ms. Jayshree, she failed to join Pachim Vihar, B 3-G(Co-ed)SSS-1617137 till date, therefore, the appointment order No. DE 04/06/406/Appt. of Lib./Pt.f./2016/6042-46 dated 23/04/2019 issued to Sh./Ms. Jayshree is hereby stand withdrawn and her candidature for the post said post is rejected with immediate effect.
