Akash (Roll No. 16310606, D.O.B 02/09/1977), was provisionally selected & nominated for appointment to the post of Librarian under post code 163/07 in Directorate of Education, Govt. of NCT of Delhi & his dossier was received in this Directorate from DSSSB vide letter No. F. 16(40)/DSSSB/P&P/1009 dated 24/12/2018.

And WHEREAS a memorandum/offer of appointment vide No. DE. 4(10)(01)/E-IV (DR)/2018/6378-79 dated 26/06/2019 was issued in r/o Sh. Akash with the direction to appear in person in this office on 05/07/2019 for documents verification but he did not appear.



And WHEREAS 1st reminder and final opportunity were afforded to Sh. Akash on the addresses mentioned in performa vide letter No. DE. 4(10)(01)/E-IV (DR)/2018/2673 dated 05/09/2019 and No. DE. 4(10)(01)/E-IV (DR)/2018/3742 dated 03/10/2019 respectively with the direction to appear in person in this office to complete all the formalities, but he again failed to appear in this office.

And WHEREAS despite providing sufficient time and opportunities to Sh. Akash, he failed to appear for documents verification in this office, therefore, the offer of appointment No. DE. 4(10)(01)/E-IV (DR)/2018/6378-79 dated 26/06/2019 issued in favour of Sh. Akash is hereby withdrawn and his candidature for the above said post is rejected with immediate effect.
