CIRCULAR

Annexure 'A'

Guidelines for Sports Competition 2019-20 (Below 12 Years) for Boys and Girls of all Govt. Schools organised by Samgra Shiksha and Directorate of Education, GNCTD.

- 1. DDE of concerned zone will be the Nodal Officer and SPE zone will be organizing Secretary of the above said competitions.
- 2. Competitions will be organized in following events for Boys and Girls separately

ì,	5 th Class	100 meters	Long Jump
ii.	3 rd -4 th Class	50 meters	Hand Ball Throw
iii.	1 st - 2 nd Class	25 meters (Hop race)	Standing Broad Jump

- 3. Age proof, Identity Card and Aadhar Card of the participant should be taken at the time of participation in the event.
- HOS concerned of the schools should verify all necessary details of the participants before sending in the entries to the Organizing Supervisor/SPE-Zone/Convenor.
- 5. An NOC supported by Medical Fitness Certificate should be taken from the participating students as a measure to safeguard the students from any mishap.
- 6. No students should be allowed to participate without proper sports kit.
- 7. Bib No. should be arranged by organizing secretary.
- 8. All the teams from school must be accompanied by a escort teacher.
- 9. Organizing Secretary /SPE-Zone/Convener will provide all necessary equipments for the events of competitions under 12-Years from the funds allocated in this regard.
- 10. It will be the sole responsibility of the Venue I/C and SPE concerned, where the competitions will be organized, to ensure the safety and security of the students. It is suggested to ensure the safety measures before organizing any event.
- 11. A First Aid kit should be made an unavoidable necessity to ensure that the first aid is given timely to any participating student in case of any eventuality.
- 12. Student shall be allowed to participate in 1 Event only.
