
Sub: Last & final opportunity for verification of documents for engagement of 6 Consultants on contract basis under Samagra Shiksha, Delhi for 2019-20.

 - v. Present and permanent address proof.
 - vi. Two photographs (one self attested and one plain)
 - vii. Photo Identity Card (Preferably Aadhar)
 - viii. The candidates shall also furnish one self attested set of the above documents.
2. After document verification eligible candidates shall be called for interview, the schedule of which will be informed separately.

3. The final merit list shall be prepared after Interview taking into account marks of academic qualification, desirable higher qualification and interview.
4. The selected candidates will be given offer of engagement as per the requirement of vacant posts under Samagra Shiksha, Delhi.
