Subject: Guidelines for Purchase of Sports Equipment in r/o Circular No. F.No. DE(62)/SS/2018-19/9870-9901, dated 23/01/2019.

In continuation to circular no. F.No.DE(62)/SS/2018-19/9870-9901, dated 23.01.2019 on the cited above, HOS/Principals/ DDOs of Govt. Schools of DOE, GNCT of Delhi may please refer to the following information for convenience in purchase of sports Equipment

1. The list, as suggested in the Annexure-I of the above mentioned circular, **is only an indicative list and not an exhaustive list.** This is clear from para (A) under guidelines regarding sports Equipment according to the MHRD dated 24.12.2018 circulated along with the UEEM circular dated 23.01.2019 referred to above which provides that the States/UTs may, if so desire, procure items beyond this list, subject to its actual requirement being certified by the head of school. Hence, it is clear that the list given in the circular is not mandatory, but suggestive for purchase of sports equipment.
2. HOS/Principals may purchase the sports equipment based on the availability of infrastructure in the school and availability of Playfield. Such a purchase may be done beyond the list given in the circular, through various channels while observing GFR-2017 and codal formalities for purchase of goods.
3. HOS/Principals may also purchase the sports equipment from "GEM" as per the provisions of GFR.
4. The amount allotted may be utilized meaningfully by the HOS/Principals concerned by choosing the sports equipment considering the need and utility, price and availability, maintenance and upkeep of the same.
5. A three Members purchase committee may be constituted at school level ensure the needful for the procurement equipment keeping mind the physical space available in the school.

In addition, to the above suggestions guidelines in circular No. F.No. DE(62)/SS/2018-19/9870-9901, dated 23/01/2019 will remain final and should followed judiciously in the interest of department.


