Sub.: Extension of Last date for filling up of Pre-Matric Scholarships Scheme for Minority Students for the year 2019-20 (CSS) on National Scholarship Portal (NSP) upto 31st October, 2019

In continuation of this office Circular No. F.DE 18-3(15)/Plg/2019-20/7331-7337 dated 09.10.2019 regarding timeline activities under the three Scholarship Schemes viz. Pre-Matric, Post-Matric and Merit-cum-Means based Scholarship Schemes for Minority Communities for the Year 2019-20, it is hereby informed to all concerned that the last date for filling up of Pre-Matric Scholarships on NSP has been extended upto **31st October, 2019**. Deadlines for 1st and 2nd level verifications will accordingly be shifted to 15th November, 2019 and 30th November, 2019 respectively.

All HOSs of Government / Government Aided / Private Schools dealing with the Scholarship Schemes of the Minority are requested for immediate action in this regard to follow up directions and dead lines of the Ministry of Minority Affairs, Govt. of India. The Verification process of applications at school level and District level have to be complete on NSP Portal within the prescribed timeline for disbursement of scholarships on time for the year 2019-20.


