## PUBLIC NOTICE

Sub : Engagement of Subject Specific Teachers (TGTs) on contrac. basis under SSA, In schools of Directorate of Education, Delhi.

1. Trained Graduate Teachers (TGTs) are proposed to be engaged on contractual basis by the UEE Mission, a society registered under the Societies Registration Act, 1860 for implementation of scheme of Samagra Shiksha Abhiyan (SSA). Subject wise tentative vacancies in each district are enclosed herewith. The vacancies are subject to variation.

2. These teachers are proposed to be engaged purely on contract basis till 31.03.2019.
3. The Consolidated salary @ of Rs. 38100/- per month will be paid to these teachers. No extra allowance will be admissible.
4. Candidates with Graduation in the specific subject with B.Ed. can apply.'
5. As per Delhi Gazette Notification dated 07.10.2011, only those who are qualified in Elementary Stage in the **Central Teacher Eligibility Test** conducted by CBSE will be considered for appointment of teachers for class VI-VIII in the schools of Delhi.
6. **Qualification** : As per Col. No.08 of the Recruitment Rules, the Essential and other qualification required for direct recruits for TGT are as follows:-

"A Bachelor's Degree (Honours/Pass) or equivalent from a recognized University having secured 45% marks in aggregate, in two school subjects of which at least one out of the following should have been at the elective level:-

(i)-English, (ii)- Mathematics, (iii) Natural/Physical Science, (iv) Social Science

Note :- Main Subject for TGT (Natural Science/Physical Science) shall be Physics, Chemistry, Biology, Botany and Zoology.

Social Science:- History/Political Science/Sociology/Geography/Psychology

\*Should have Qualified CTET from CBSE.

Provided further that the requirement as to minimum 45% marks in the aggregate in graduation level shall be relaxable in case of :-

- a. Candidates who passes a Post Graduate Qualification in any of the teaching subject listed above,
- b. Belonging to SC/ST
- c. Physically handicapped candidates

(II) Degree/Diploma in Training Education of SAV certificate.

(III) Working knowledge of Hindi.

- (i) B.A (Honours) in one of the Modern Indian Languages (MIL) concerned or BA with Mil concerned as one of the Elective subject from a recognized University having 45% marks in aggregate with one additional language or one school subject at Degree Level.

OR

Equivalent Oriental Degree in MIL concerned from a recognized University having 45% marks in aggregate

OR

(For appointment as Hindi Teachers only) Sahitya Rattan of Hindi Sahitya Sammelan Prayag having secured at least 45% marks in aggregate with English in Matriculation provided further that the requirement as to the minimum 45% marks in the aggregate shall be relaxable in the case of (a) candidate who possess a Post Graduate Qualification in MIL concerned from a recognized University (b) candidates belonging to SC/ST (c) Physically handicapped candidates.

- (ii) Degree/Diploma in teaching

OR

Senior Anglo Vernacular Certificate

- (iii) Knowledge of Hindi is essential

**(Amended Rules for Urdu)** : Candidates who possess qualification equivalent to secondary (10<sup>th</sup> ), Sr. Secondary (12<sup>th</sup>), or equivalent from recognized/approved Madarsas and for admitting to B.A. degree and after that higher courses like B.Ed from a recognized institution by the UGC are also eligible to apply

**Note-1** "The candidate should have studied the subject concerned as mentioned in the RRs in all part/years of graduation. The elective word may also include main subject as practiced in different Universities".

**Note-2** Candidates, who have studied a given subject in only two years of Graduation with three papers each having 100 marks but studied the same subject at the Post Graduation level too shall be considered eligible to apply for the post of contractual TGTs.

Recruitment Rules in detail in respect of all posts are available on the website of Directorate of Education – [www.edudel.nic.in](http://www.edudel.nic.in). Those who fulfil educational qualification, as specified in Recruitment Rules (RRs) read Note 1 and Note2, shall only apply.

**7. Age:-**


1. 30 years for male candidates and 40 years in case of female candidates as on 13/01/2019.
2. Age relaxable for 5 years in case of SC/ST candidates admissible.
3. Age relaxable for 3 years in case of OBC candidates admissible.
4. Age relaxable for candidates with disabilities- 10 years (General),  
15 years in the case SC/ST (PH) and 13 years in the case of OBC(PH).

8. The certificate of OBC should be issued by authority of GNCT of Delhi. For SC/ST candidates from other States can also be considered.
9. The Teachers would be engaged on the basis of merit in academic performance of the applicant at different level (X, XII or equivalent, Graduation and B.Ed.).
10. Reservation will be provided as applicable under rules in the Directorate of Education.
11. Teachers employed on contract can apply only in **one district** for a **given post**.  
**Note :** In case any candidate applies in more than one district his/her application will be cancelled.
12. Willing candidates may apply online on our website [www.edudel.nic.in](http://www.edudel.nic.in) latest by 13/01/2019 in **anyone of the district of their choice**.
13. The applicant shall fill up his or her name as recorded in the certificate of Secondary/Sr. Secondary Board Examination, failing which application shall be summarily rejected. No change in the application form will be entertained after submission.
14. The application shall be submitted online till 13/01/2019 by 5pm. The result will be displayed on website on 18/01/2019.

**The module for on-line application will be operational by 05/01/2019 by 1:00 pm onwards.**
