



- And Whereas, **Mr./Ms. ANUSHAIYA MEENA** did not report in person on the scheduled date and time as given in the offer of appointment issued to him vide letter of even no. dated **27.09.2019**, Public Notice dated 26/10/2019 and Final Reminder of even no. dated **09.12.2019** and neither has intimated any reason to the Directorate for not reporting and has not accepted the offer of appointment.
- As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment. **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**
