Consequent upon selection through Delhi Subordinate Services Selection Board to the post of Lecturer Sanskrit (Male) and with the Prior approval of the Competent Authority, the candidate is hereby appointed purely on Temporary and provisional basis to the post of Lecturer Sanskrit (Male) vide post code 116/17 in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4800 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her. The Candidate has been medically examined by the Govt. Hospital and declared FIT vide their individual report placed in their respective dossier. In the case of candidates who are referred to Govt. Hospital for medical examination and their medical fitness certificated is awaited, the Provisional Appointment is hereby given in relaxation of FR 10 and drawl of pay and allowances for a period not exceeding 2 months is subject to medical examination within 2 months from the date of Provisional Appointment and if the candidate is subsequently found medically unfit his/her services shall be terminated after the expiry of the period of 1 month from the date of communication to him of the findings of the medical officer/board. Further, the candidate has sought exemption from Medical examination by virtue of being already in Government Service. The candidate is hereby directed to report to their respective place of posting latest by 21/11/2019, failing which his/her appointment shall stand cancelled without any further communication.
