This is in reference to letter U.No 100(3)/RN/2022/144/A-2550 dated from Lt. Governor's Secretariat, Raj Niwas, Delhi regarding "Har Ghar Tranga"- Action Points (Annexure-"A"), and in addition to the circular no. F.42/DE/PE & NI/2022-23/714-62 dated 27.07.2022 regarding activities related to "Har Ghar Tiranga", issued by Physical Education Branch, Directorate of Education (Annexure-"B").

Under the "Har Ghar Tiranga" campaign, the Tricolor is proposed to be hoisted atop of more than 20 crore houses as well as govt. and private institutions/ establishments across the country from August 13th to 15th, 2022 through public participation.

Accordingly, all HOSs and HOOs are directed to take following actions under "Har Ghar Tiranga" campaign to celebrate 75th year of Independence "Azadi Ka Amrit Mahotsava" in Directorate of Education. GNCT Delhi.

- All Government/Aided/Private schools and all offices falls under Directorate of Education, GNCT of Delhi will hoist Tricolor atop of their building from 13th August, 2022 to 15th August, 2022.
- 2. To popularize the "Har Ghar Tiranga" initiative and to ensure maximum public participation to make the programme a grand success, all Government/ Aided/Private schools and offices will launch a special Information, Education and Communication (IEC) campaign for sensitization and awareness of students, parents and staff with immediate effect.
- Special assembly and awareness program may be conducted in every school for maximum participation of students, parents and staff members. SMC members may also be involved to motivate the parents and people living in the vicinity.
- 4. Social media may be used for popularizing the "Har Ghar Tiranga" campaign and to encourage the students, parents, and staff members to upload selfie with a Flag on the portal "https://harghartiranga.com".
- 5. To ensure timely availability of Tricolor and success of campaign, the requirement of flags and their procurement may be planned well in time. Students, parents and staff members may be encouraged to purchase the flags.

- 6. All govt. schools/offices under DoE may procure the flags either through the registered vendors on the GEM portal or through Self Help Groups (SHGs)/ Other manufactures/suppliers.
- Government schools are directed to utilize the SMC Funds to procure Tricolor, all other offices under Directorate of Education may procure the Tricolor from contingency fund.
- 8. Schools may organize 'Prabhat Pheries" by school students from 11th August, 2022 to 14th August, 2022 to create awareness among people regarding "Har Ghar Tiranga" campaign and to hoist Tricolor atop of their houses/buildings in neighborhood area.
- 9. The flag code of India has been amended vide order dated 20th July, 2022 which allows that "Where the flag is displayed in open or displayed on the house of a member of public, It may be flown day and night." Salient features of the flag code of India 2002 are attached at Annexure-"C". It may be ensured that all actions may be taken as per the Flag Code.
- 10. All DDE(District) will be the Nodal officer for their concern district to monitor the "Har Ghar Tiranga" campaign on daily basis and encourage HOSs to ensure maximum participation from their schools.

"Har Ghar Tiranga" : Action Points

Hon'ble Union Home Minister and Hon'ble Union Minister of Culture on 17.07.2022 held a meeting with all the Lieutenant Governors and Administrators of Union Territories and Chief Ministers to review the preparations for the "Har Ghar Tiranga" campaign launched by Hon'ble Prime Minister to celebrate "Azadi Ka Amrit Mahotsava" (AKAM).

Under this campaign, the Tricolor is proposed to be hoisted atop more than 20 crore houses as well as govt. and private institutions/establishments across the country from August 13th to 15th, 2022 through public participation.

Accordingly, as desired by the Hon'ble Lt. Governor, it is requested that immediate necessary action may be undertaken on the following:

- i. Tricolor to be hoisted on all the Govt. buildings, public places & important locations from the 13th, August-15th, August.
- Concerted efforts to be made by all Departments of GNCTD, MCD, ii. NDMC, DDA & Delhi Police for popularizing the "Har Ghar Tiranga" initiative for ensuring maximum Jan Bhagidari to make the programme a grand success. A special Information, Education and Communication (IEC) Campaign to be launched from 22nd, July for public sensitisation and awareness.
- iii. Social media may be used for popularizing the campaign. Pictures of the campaign to be uploaded on the portal "https://harghartiranga.com"
- For the success of the campaign the requirement of flags and their iv. procurement may be planned well in advance. The citizens may be encouraged to purchase the flags.

- v. The departments may procure the flags either through the registered vendors on the GeM Portal or through Self Help Groups (SHGs)/Other manufacturers /suppliers. Alternatively, the Ministry of Culture can also be approached to procure a specified number of flags at prescribed rates and the requirements must be indicated to the Ministry latest by 20th, July. Simultaneously appropriate accounting procedure may be devised so that realisation from sale proceeds of the flags sourced through the Central Govt. channels on credit basis are routed back to the flag producers.
- vi. From July 22nd, the national flag to appear on the homepage of all the websites of the various Govt. departments & undertakings.
- vii. "Prabhat Pheris" by school students to be organized from 11th, August to 14th, August.
- viii. An Action Plan on the above may kindly be shared for perusal of Hon'ble LG before 22nd July 2022. It may be ensured that all actions may be taken as per the Flag Code.

- 3. Stories of Martyrs related to Hoisting of the National Flag during the Assembly
- 4. Patriotic Songs by Students.
- 5. Painting on the theme of National Flag.
- 6. Slogan Writing related to the National Flag.
- 7. Selfie Point to be made in each school for a selfie with the Tricolor Flag.
- 8. Flag Hosting Ceremony*

- 1. The Indian National Flag represents the hopes and aspirations of the people of India. It is the symbol of our national pride and there is universal affection and respect for, and loyalty to, the National Flag. It occupies a unique and special place in the emotions and psyche of the people of India.
- 2. The hoisting/use/display of the Indian National Flag is governed by the Prevention of Insults to National Honour Act, 1971 and the Flag Code of India, 2002. Some of salient features of the Flag Code of India, 2002 are listed below for the information of the public:
 - a) The Flag Code of India, 2002 was amended vide Order dated 30st December, 2021 and National Flag made of polyester or machine made Flag have been allowed. Now, the National Flag shall be made of hand spun and hand woven or machine made, cotton/polyester/wool/silk khadi bunting.
 - b) A member of public, a private organization or an educational institution may hoist/display the National Flag on all days and occasions, ceremonial or otherwise, consistent with the dignity and honour of the National Flag.
 - c) The Flag Code of India, 2002 was amended vide Order dated 19th July, 2022 and clause (xi) of paragraph 2.2 of Part-II of the Flag Code of India was replaced by the following clause:-
 - (xi) "where the Flag is displayed in open or displayed on the house of a member of public, it may be flown day and night;"
 - d) The National Flag shall be rectangular in shape. The Flag can be of any size but the ratio of the length to the height (width) of the Flag shall be 3:2.
 - e) Whenever the National Flag is displayed, it should occupy the position of honour and should be distinctly placed.
 - f) A damaged or dishevelled Flag shall not be displayed.

- g) The Flag should not be flown from a single masthead simultaneously with any other flag or flags.
- h) The Flag should not be flown on any vehicle except of the dignitaries mentioned in Section IX of Part III of the Flag Code, such as President, Vice-President, Prime-Minister, Governors etc.
- i) No other flag or bunting should be placed higher than or above or side by side with the National Flag.
