## CIRCULAR

Sub: Involving of Private Academies / Clubs / Individuals for coaching of student players in various sports in Government schools.

Directorate is running a scheme for broad basing of sports at grass root level by involving various academies / clubs / individuals trainers, in the localities of Delhi for imparting training and coaching to the students players in the Government schools of Dte. of Education.

Under the scheme requisite space is provided by this Dte. in the Govt. schools and the academies / clubs / individuals trainers involved have to provide training and coaching to student players of that particular school or nearby Govt. schools free of cost. Simultaneously, they can also impart training and coaching to student players of the nearby non-government schools, on reasonable charge basis. However, the ratio of student players for receiving training should be 50:50 of government school/Govt. aided schools/non aided Govt. recognized school students & non government school student players.

At present under the scheme 50 academies / clubs / individuals trainers are running in the different schools of this Directorate in different games.

Whereas, during the visit of these academies / clubs / individuals trainers nominated under the scheme for imparting training and coaching to the students players in the Government schools of Dte. of Education, it has been observed that, almost all the academies / clubs / individuals trainers were found providing training and coaching to the paid students only and there are very small number of governments schools students who are getting training and coaching in these centers and thus not following the terms and conditions of the scheme. This act of these academies /clubs /individuals trainers is defeating the main purpose of the scheme.

Hence, to provide full benefit of this scheme to the government school/Govt. aided schools/non aided Govt. recognized school students, it is directed that:

- 1. All the HoS where the academy is being run will display a board on the proper place preferably at the entry gate of the building showing the name of the academy, name of the game and the facilities being provided in the academy.
- All the HoS where the academy is being run will motivate the students of his/her school and coordinate with the HoS of nearby government schools to use the facility available in the academy.
- 3. All the DDEs concerned are also directed to call meeting of the HoS of the school where the academy is being run and the HoS of the nearby schools in the routine interval to give wide publicity of the scheme.
