Subject: Regarding online verification of applications on e-district portal in r/o State Funded Scheme "Reimbursement of Tuition fees to the Minority Students of Classes I to XII" for 2020-21

The attention of all DDE (Zones) and Head of Recognized Unaided Private Schools are drawn to the circular No. DE-18-1(63)/PLG/2021-22/4512-4518 dated 07/07/2022 (copy attached) wherein they were requested to complete online verification on e-district portal in r/o State Funded Scheme "Reimbursement of Tuition fees to the Minority Students of Classes I to XII" for 2020-21 by 15/07/2022 at school level & by 25/07/2022 at zonal level.

Further, the applications of non-eligible applicants, if any, must be rejected.

Subject: Regarding online verification of applications on e-district portal in r/o State Funded Scheme "Reimbursement of Tuition fees to the Minority Students of Classes I to XII" for 2020-21

Kind attention of all DDE (Zones) and Head of Recognized Unaided Private Schools are drawn to various circulars issued on the subject cited above, vide which it was requested to complete online verification as per eligibility criteria of the said scheme. In this regard, all DDE (Zones) have attended a Meeting in Revenue Deptt on 27/05/2022 and again a Meeting-cum-Training was organized on 30/06/2022 in the conference room of the DoE. During both meetings, the demo/presentation was given by the programmer of Revenue Deptt to clarify eligibility criteria of the scheme and all technical aspects pertaining to online verification on e-district portal.

Further, all DDE (Zones) and Head of Recognized Unaided Private Schools are informed that Delhi Minority Commission (DMC) has directed vide their Minutes of the Meetings bearing No. F.06/92/DMC/Misc./2021/2049-2056 dated 30/06/2022 that online verification on e-district portal must be completed by 15/07/2022 at school level & by 25/07/2022 at zonal level.

Besides the above, all DDE (Zones) and Head of Recognized Unaided Private Schools are informed that the DMC has shown displeasure on inordinate delay in completion of online verification of applications for the year 2020-21.

Therefore, all DDE (Zones) and HoSs are directed to complete online verification for the year 2020-21 by the stipulated time to enable the Revenue Deptt to make payment to eligible minority students for 2020-21.
