Cancellation of offer of appointment & Candidature to the post of TGT-Sanskrit (Male)
Post Code-116/12 in r/o Sh. Rakesh Kumar (Roll No. 52000478)

Whereas, Sh. Rakesh Kumar, (D.O.B. 15.07.1981), Roll No. 52000478, category-UR, has been nominated by the Delhi Subordinate Service Selection Board for appointment to the post of TGT-Sanskrit (Male) against post code 116/12 vide letter No. F.1(155)/DSSSB/P&P/2012/460 Dated 01.04.2022. and vide Supplementary Result Notice No. 822 vide letter No.F.No.41/TGT/Sanskrit/Male/Int.cell/DSSSB/2016-17/3455-65 Dated 15.12.2021 in the Directorate of Education, Govt. of NCT of Delhi.

Whereas the offer of appointment for acceptance of offer and for document verification issued vide No.DE3(77)/E-III/DR/2016/333 Dated 05.05.2022 for 11.05.2022 and 1st reminder vide letter No. 458 Dated 23.05.2022 for 02.06.2022, IInd reminder vide letter No. 587 Dated 22.06.2022 for 02.07.2022 and final reminder vide letter No. 660 Dated 05.07.2022 for 15.07.2022 issued, but the candidate Sh. Rakesh Kumar (Roll No. 52000478) did not turn up neither for acceptance of offer nor for document verification.

Therefore it is presumed that Sh. Rakesh Kumar (Roll No. 52000478) candidate for the post of TGT-Sanskrit (Male), Post Code-116/12 is no longer interested in joining the above mentioned post and hence the competent authority has cancelled the offer of appointment & candidature vide No. DE.3(77)/E-III/DR/2016/333 Dated 05.05.2022 and subsequent reminders in this matter.
