ORDER

Cancellation of Candidature for the post of Assistant Teacher (Nursery)-88/17

Whereas, Ms. Reena DOB 10.11.991, Roll No. 2640009254 has been nominated by the DSSSB vide letter No. F.1 (383)/DSSSB/P&P/2017/4274 dated 28.10.2020 for appointment to the post of Assistant Teacher (Nursery) under Post Code -88/17 in Directorate of Education, Govt. of NCT of Delhi. During the course of preliminary scrutiny of the candidate's dossier, it has been observed that the candidate has possessed her (Primary), Nursery Teacher's Training Programme from Shiksha Bhavan, Rohini, Delhi. The candidate was issued a deficiency memo vide dated 09/12/2020 and subsequent two reminders dated 21/01/2021 and 05/03/2021 to the candidate to provide NCTE recognition certificate of the institution through which the candidate has possessed her (Primary), Nursery Teacher's Training Programme. Despite providing ample opportunity to the candidate, the candidate failed to produce the requisite certificate.

Whereas, it has clearly been mentioned in the advertisement No. 04/17 dated 20.12.2017 that the eligibility criteria for the said post was "Diploma/Certificate in Nursery Teacher Education Programme of duration of not less than two years or B.Ed. (Nursery) from a **recognized institute.**"

Therefore, the candidature in r/o Ms. Reena DOB 10.11.991, Roll No. 2640009254 stands cancelled, as the candidate does not fulfill the eligibility criteria as required in the said advertisement.
