ORDER

Cancellation of Offer of Appointment to the post of PGT (Computer Science) Female,
Post Code 151/17

Whereas, **Ms. Nishi Jain**, D.O.B. 14/12/1994, Roll No. 110415100003 has been nominated by the DSSSB for the post of PGT (Computer Science)- Female against Post Code 151/17 vide letter No.F1(401)/DSSSB/P&P/2017/4596 dated 07/01/2020 vide Supplementary Result Notice No. 728 dated 10/12/2020.

2) And whereas, on scrutiny of the documents available in her e-dossier, it is found that the candidate has done B.Tech. plus Post Graduation Diploma in Computer Application plus 326 days of teaching experience from Kendriya Vidhalaya and 576 days of teaching experience from Men's Power and Moral Activities, Social Society (Reg.) N.G.O., East Azad Nagar, Delhi.

3) And whereas, In this regard an Expert Committee was constituted to decide whether a teaching experience from an N.G.O. can be considered for the post of PGT (Computer Science) or not. RRs of PGT (Computer Science) are as follows:-

"B.E. or B. Tech. (computer Science/IT) plus Post Graduation Diploma in Computer Application or B or C level Diploma from DOEACC, Ministry of Communication and IT plus one year teaching experience.

or

M. Sc. (Computer Science)/MCA plus one year Teaching Experience.

or

Master of Engineering or M. Tech. (Computer Science/IT)."

4) And Whereas, the Expert Committee constituted for the above case has recommended decided that:

"While teaching the students in the N.G.O. Ms. Nishi Jain did not acquire the undergraduate degree (B.E. or B.Tech. (Computer Science/IT)). Therefore, the teaching experience acquired from the N.G.O. does not stand valid."

5) And whereas, the said recommendation of the Expert Committee was placed before the Competent Authority. The Competent Authority in agreement with recommendation of the Expert Committee has decided that Ms. Nishi Jain does not fulfill the RRs of PGT (Computer Science) as advertised by DSSSB in advertisement no. 04/17. Hence, the candidature in respect of **Ms. Nishi Jain, D.O.B. 14/12/1994, Roll No. 110415100003** is hereby cancelled and the dossier returned to the DSSSB.
