**ORDER**

**Cancellation of offer of Appointment and candidature to the post of TGT NATURAL SCIENCE (FEMALE) POST Code 136/17**

Whereas, **Ms. REKHA CHAUDHARY**, D.O.B. 06/12/1989, Roll No. 111213600240 has been nominated by the DSSSB for appointment to the post of **TGT NATURAL SCIENCE FEMALE**) against Post Code **136/17** vide Result Notice No. 458 dated 30/05/2019 in the Directorate of Education, Govt. of NCT of Delhi.



Whereas, it is found that the said candidate has not joined their allotted school till date and moreover no extension request has been received so far in this office.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, It may be considered by the ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore it is presumed that the said candidate is no longer interested in joining the above mentioned post and hence the competent authority has cancelled the order of appointment and candidature bearing No. DE.3 (12) / DRC (E-III) / TGT (Natural Science) /Female/2019/ 1437 dated 31/10/2019 with posting ID: 201900273 and Emp Id. 20197000 issued to **Ms. REKHA CHAUDHARY**, D.O.B. 06/12/1989, Roll No. 111213600240.
