**ORDER**

**Cancellation of Offer of Appointment and candidature to the post of TGT( Natural Science ) Male Post Code 135/17**

Whereas, **Sh. Vikas Kumar Jain, D.O.B. 15.07.1983 Roll No. 110613500803** was nominated by the DSSSB vide letter No. F.1(391)/DSSSB/P&P/2017/5277 dated 17.03.2020, Result declared vide Result Notice No. 764 dated 23.03.2021 in the Directorate of Education, Govt. of NCT of Delhi, for the Post of TGT (Natural Science)(Male) under Post Code 135/17, Accordingly, an Offer of Appointment was issued to him vide this Directorate Memorandum dated 10.08.2021 and the candidate was called for document verification on 09.09.2021 at 11:00 a.m.

And whereas, during document verification it was found that the candidate had submitted the Teaching Experience Certificate issued from a Private School, which is not applicable for age relaxation as per advertisement No. 04/17 for the post of TGT (Natural Science)Male, Post code 135/17 issued by DSSSB.

And whereas, as per Advertisement no. 04/17 issued from DSSSB, condition for age relaxation in respect of Guest/Contractual Teacher is mentioned as, "Relaxation in upper age as a one time measure up to the actual time spent as guest/contract teacher in Dte. Of Education, subject to maximum of 5 years provided they have worked for atleast 120 working days in the that particular year(this would be applicable to those Guest/Contract teachers who worked for the academic years 2012-13, 2013-14, 2014-15, 2015-16, 2016-17).

And whereas, the candidate has been nominated for the post of TGT (Natural Science) Male under Post Code-135/17 vide Result notice no. 764 dated 23.03.2021 of DSSSB under UR category.

And whereas, the candidate was 34 years 6 months and 16 days old on the last/closing date i.e. 31.01.2018 of application form submission for the above mentioned post. The candidate is overage by 2 years 6 months and 16 days under UR category as the prescribed age limit for the post of TGT(Natural Science)Male, Post Code 135/17 is below 32 years as advertised by DSSSB for the said post vide Advertisement No. 04/17.

And whereas, as the candidate submitted the teaching experience certificate of a Private School namely Shri Lal Bahadur Shastri Vidya Mandir, Junior High School, Palia Kalan, Kheri, UP & Maharaja Agarsain Public School, Narela, Delhi-110040 which is not eligible for grant of age relaxation to the candidate for the post of TGT (Natural Science) Male, Post Code-135/17 which is granted in lieu of working as Guest/Contract Teacher in Directorate of Education, GNCT of Delhi.

Therefore, as the candidate is not eligible for age relaxation as the candidate has submitted the Teaching Experience Certificate of a Private School and not actual time spent as Guest/Contract Teacher in Directorate of Education, GNCT of Delhi for the academic years 2012-13, 2013-14, 2014-15, 2015-16, 2016-17 hence the Competent Authority has cancelled the Offer of Appointment bearing No. DE.3(13)/DRC/E-III/TGT/Natural Science/Male/2019/ 3300 dated 10.08.2021, issued in respect of **Sh. Vikas Kumar Jain, D.O.B. 15.07.1983 Roll No. 110613500803** under Post code TGT (Natural Science)(Male) 135/17 and his candidature is cancelled for the said post. Dossier of the candidate is returned to DSSSB.
