Consequent upon selection through Delhi Subordinate Services Selection Board to the post of LECTURER COMP. SC.(FEMALE) vide post code 151/17 in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4800 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her. The Candidate has been medically examined by the Govt. Hospital and declared FIT vide her individual report placed in her respective dossier. In case of OBC candidate the appointment will be provisional at the time of joining the candidate will have to submit an undertaking to concerned Head of the School/office that "It is hereby undertaken that the information furnished by me is true and correct and the OBC certificate is as per provisions contained in DSSSB advertisement number 04/17 and in the event of being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, my candidature / appointment is liable to be cancelled / terminated automatically without any notice and action can be taken against me by the department as per Rules'. Subsequently, the OBC verification report will be checked by the DDE concerned. If the OBC certificate of the candidate concerned is found invalid, his/her candidature will be terminated with immediate effect. The candidate is hereby directed to report to her respective place of posting latest by 13.12.2021, failing which his/her appointment shall stand cancelled without any further communication.
