## **CIRCULAR**

Sub:- Review of performance and renewal of allotment of Pvt. Academies/ Clubs/ Individual who have been allotted playgrounds under the scheme "Involving various Sports academies/ clubs/ individual trainers into coaching of student players in various sports in Government Schools."

Dtc. of Education with an aim to broad base and develop the sports in Delhi, invited applications under the Scheme "Involving various Sports academics/ clubs/ individual trainers into coaching of students players in various sports in Government Schools" vide Circular No. F.DE/41/Sports/2018/21554-21603 dated 19.01.2018 after the allotment these academics/ clubs/ individual trainer was again renewed for the two years vide circular no. F.1/DDE/Sports/Pvt. Academics/2020/460-509 dated 17.07.2020.

The interested sports academies/clubs/individual trainers applied under the scheme and subsequently after scrutiny of the applications received, school playgrounds/ play area were allotted to them to provide coaching to students as per the terms & conditions of the scheme. Further, the Sports academies/ clubs/ individual trainers were directed to submit report of students undergoing training on monthly basis in the prescribed proforma.

As per the point no. 12 (f) of the scheme, the permission will be accorded for 2 years, initially from the date of issue letter. Each Academy/Club/Individual trainer will submit its performance report on Quarterly basis. The performance of each academy/club/individual will be reviewed from time to time and if found satisfactory and required by the Directorate, the arrangement will be renewed for another period of 2 years & 1 year respectively.

Since, the allotment of maximum academies has completed two years and their extension/ termination of the allotment based on their performance review is to be initiated. Also, the performance of other sports academies/ clubs/ individual trainers will be reviewed as significant time has elapsed since the playgrounds have been allotted to them.

To evaluate the performance, following actions are required on the part of Sports academies/clubs/individual trainer.

For Sports academics/ clubs/ individual trainers who have completed two years of allotment

To submit application for renewal along with supporting documents on mail ID <a href="mailto:ddesportsdelhi@gmail.com">ddesportsdelhi@gmail.com</a> up to 28th February 2023, so that their performance be reviewed and decision be taken accordingly. The performance should be submitted in the prescribed format attached herewith duly countersigned and with remarks of H.O.S. concerned.

The brief of initiatives taken by them which had a positive impact may also be attached with any practical suggestion/ feedback.

In case application is not received by the time prescribed, it will be presumed that the academy/ club/ individual trainers is not interested in continuing the practice at the allotted playground and the allotment will be cancelled without giving any further notice/

The last date of submission of renewal request is February 28th, 2023.
