CIRCULAR

Sub: Instructions for Admissions to Class XI in Humanities/Vocational streams for the session 2016-17.

All Heads of Govt. Schools are to ensure that their OWN STUDENTS / GOVT. FEEDER/GOVT AIDED SECONDARY FEEDER SCHOOLS STUDENTS are given admission in class XI in the streams for which they are eligible. The admission criteria will be as per Circular No. DE.23(28)/Sch.Br./2016/815 dated 31.05.2016.

The Heads of Schools must ensure that all the eligible studentss of their OWN SCHOOL /GOVT. FEEDER SCHOOL/GOVT. AIDED SECONDARY FEEDER SCHOOL are given admission. Only after all the students of OWN SCHOOL / GOVT. FEEDER SCHOOL/GOVT. AIDED SECONDARY FEEDER SCHOOL have been admitted and if seats are vacant then the HOS will consider Non Plan Admission.

• **Non-Plan Admission Procedure (Manual) for Govt. Aided/ Other Recognized Schools.**

All the Heads of Govt. schools are directed to adhere to the following instructions in letter and spirit while preparing the merit list for the Non Plan Admission in case seats are available:

1. Application form along with filled option form for such admission are to be submitted by the students directly in the school where they are seeking admission.
2. In order to observe transparency a common Merit List (ML-1) for all students of Govt. Aided Schools and other Recognized Schools will be prepared for Humanities and Vocational stream separately (subject to availability of seats).
3. The eligibility criteria are as per circular No. DE.23(28)/Sch.Br./2016/815 dated 31.05.2016.

4. The CBSE / Concerned Board roll numbers of such students must be mentioned in the merit list.

5. The grades of the concerned students must be properly checked and verified by the Head of School from the website of the concerned Board before granting admission.

5. In addition to above the following instruction should also be complied with:

- Prepare the merit lists based on CGPA & Grade points of the required subjects as per Circular No. DE.23(28)/Sch.Br./2016/815 dated 31.05.2016).
- The HOS has to prepare the merit list according to the total grade points keeping in view that a student must have, obtained minimum qualifying grades in each subject as per admission criteria for Humanities & Vocational streams.
- It is also important to note that just getting minimum qualifying grade & CGPA does not guarantee admission in a particular stream.

- The DDEs (Zone) are also directed to monitor the admission process personally and closely and it is their responsibility to ensure that no rules are violated. Transparency is to be maintained at all levels.
- HOSs must ensure compliance of relevant circulars.
- **The subject in which a student has failed in Class X cannot be opted in class XI.**
- **For giving Economics as a subject a student must have at least 6.00 CGPA.**
- **For giving Mathematics as a subject a student must have secured at least C1 Grade without asterisk in Mathematics.**
- It has been noticed that some invalid combination of subjects are being offered to students which are creating problem at CBSE/University level. All Heads of Schools are to offer those subjects which are in line with CBSE guidelines as well as applicable at admission at university level. In case of any query, the HOS may contact CBSE for clarification.
- The last date for admission is 16th August 2016 at the level of HOS for Class XI.




